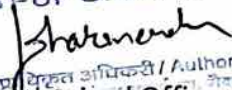
The undersigned proposes to sell the assets more fully described in the Schedule of Sale Notice.

- a. The property/ies will be sold in "As is where is", "As is what is", and "Whatever there is" condition, including encumbrances if any. (There are no encumbrances to the knowledge of the Bank).
- b. The bidder will also make the due diligence of the properties any liability from any Govt. or the successful bidder will pay any other department.
- c. Auction / bidding shall be only through "Online Electronic Bidding" through the website <http://Baanknet.com/>. Bidders are advised to go through the website for detailed terms before taking part in the e-auction sale proceedings.
- d. The properties will not be sold below the Reserve Price.
- e. The property can be inspected with Prior Appointment with Authorized Officer from 28.09.2026 to 29.09.2026 (working days) between 03:00 PM to 05:00 PM.
- f. The sale will be done by the undersigned through e-auction platform provided at the website <http://Baanknet.com/> on the date and time mentioned above. Further intending Bidders/purchasers are requested to complete Registration and e-KYC and add Bank details. Once registration and e-KYC is successfully completed, the intending Bidders/Purchasers have to deposit amount of EMD before last date and time of EMD. - j. The successful bidder shall deposit 25 % of the sale price (inclusive of EMD already paid), immediately on the sale being knocked down in his/ her favor and the balance within 15 days from the date of confirmation of sale. If the successful bidder fails to pay the sale price as stated above, the deposit made by him shall be forfeited.
- k. All charges for conveyance, stamp duty and registration etc., as applicable shall be borne by the successful bidder only.

Where the sale consideration, of the property to be transferred is Rs. 50 Lac and above the successful bidder will have to deduct Tax Deducted at Source) TDS @ 1% on the sale proceeds and deposit the same by furnishing the Challan in Form 26QB and submit the original receipt of TDS certificate to the Bank.
- m. Authorized Officer reserves the right to postpone/cancel or vary the terms and conditions of auction without assigning any reason thereof.
- n. The SA no.277/2026, titled M/s B L Yarn Traders LLP & Others Vs Canara Bank, is pending before the Hon'ble DRT. However, there is no interim stay, injunction, or any restraining order passed by the Hon'ble DRT against the properties mentioned in the sale notice.
- o. The borrower/guarantors in the loan account of M/s B L Yarn, namely Sh. Jagmohan Garg, Sh. Richu Garg, and Sh. Umesh Kumar Garg, have filed applications for initiation of the Personal Insolvency Resolution Process (PIRP) before the Hon'ble NCLT, Chandigarh. However, none of the said applications has been admitted by the Hon'ble NCLT till date, and the Bank is contesting the same. Further, there is no stay, injunction, or any restraining order passed by the Hon'ble NCLT in respect of the secured assets/properties mentioned in the sale notice. Accordingly, there is no legal restraint on the Bank from proceeding with the sale of the secured assets in accordance with the provisions of the SARFAESI Act, 2002 and the applicable rules.
- p. As per banks record, the outstanding dues of the Local Self Government against the Property and dues of electricity department are not known to bank, as no notice received. For the same. The Purchaser is liable to incur the dues, if any.
