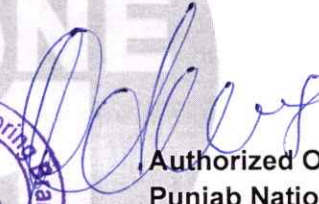
TERMS AND CONDITIONS OF E-AUCTION SALE-
