

DEMO ON TECH TO PREVENT SEWAGE INFLOW INTO RIVER

TIRUNELVELI: A chemical-free electrochemical technology to prevent untreated sewage from directly entering the Thamirabarani was demonstrated at Sindhupondurai on Friday. In a statement, the Tirunelveli Municipal Corporation said the technology uses three integrated electrochemical processes: electro-coagulation, electro-oxidation and electro-flotation. "Its dual reactors will treat sewage at the outfall itself and destroy pathogenic microbes before the treated water is discharged. The demo was conducted as part of a proposed pilot implementation by the district administration and the corporation to treat sewage before it reaches the river. The demonstration was explained by representatives of a company in the presence of Tirunelveli MP C Robert Bruce and TMC superintending engineer Ashok Kumar," the corporation added.

Kannadigas among 70 stuck in Tibet

THIRTY-FIVE people from Karnataka, part of a 70-member tourist group stranded in Tibet, have alleged that the state government have not been adequately responsive in facilitating their evacuation from the disaster struck site.

The group, currently in Nyalam in the Tibet Autonomous Region (TAR), said they have filled the Karnataka government's registration form for stranded persons. According to Krishna, they subsequently received a call asking what assistance they required. "We told them we wanted evacuation, but after that there was no update," he said.

Krishna, a Bengaluru resident travelling with the group, said they contacted several departments and were given multiple numbers to reach out to. They also sent emails to around 45 official addresses seeking assistance, but did not receive a

response, he alleged.

The Karnataka government had said the Chief Minister, Deputy Chief Minister and Revenue Minister are closely monitoring the situation and are in constant touch with the MEA and Karnataka Bhavan in New Delhi for the safe return of people from the state.

The State Emergency Operations Centre has so far collated details of 28 people from Karnataka stranded or missing in Nepal and the TAR. Four have been confirmed safe, while efforts are underway to trace the remaining 24.

The larger group of 70 tourists includes people from Karnataka, Chennai, Mumbai and New Delhi. They were forced to leave Saga after Chinese authorities reportedly asked them to vacate the area by Friday morning and subsequently reached Nyalam.

The group is coordinating with its Bengaluru-based tour operator.

Not invited to govt functions, says councillor

Councillor Rexline said that the TVK Minister was unnecessarily talking about films at school functions, which would distract the children; hence it should be stopped, she said.

Meanwhile, Mayor Periyasamy alleged that the supporters of a TVK minister are threatening the contractors. "The Department of Vigilance and Anti-Corruption should take action against them", the Mayor demanded.

Sanitation worker dies days after suicide bid

Madurai: A contract sanitation worker of the Usilampatti Panchayat Union who attempted suicide after being removed from service died 11 days later while undergoing treatment at the Madurai Government Rajaji Hospital on Friday. The deceased was P Sundaraj who had been working as a contract sanitation worker since 1996. A senior district administration official said Sundaraj was removed from service about two months ago following alleged neglect of duties. Despite warnings, he allegedly failed to improve his work, the official said. Sundaraj's relatives staged a protest at Peraiyur.

RECENTLY, environmentalists demanded the government to scrap the project saying that its location close to Pallikaralai marshland would cause flooding. A few weeks ago, SDAT officials visited Veer Savarkar Sports Complex in Gujarat. The purpose of the visit, as per sources, was to see the possibility of creating a similar facility in the state. The authority will identify suitable site, which will likely be in Chennai, and construct a sports complex.

The foundation stone for the project was laid by then Chief Minister M K Stalin on February 18 2026. The original contract was disclosed to exchanges on February 20, 2026 by RPP

Infra Projects Limited. The company, in its submission to National Stock Exchange on Thursday, said it received formal communication from SDAT on August 12, 2026 confirming the work order had been cancelled.

The company said that it had already begun work under the order and incurred significant costs before the abrupt cancellation.



Crypto currency investment scam: At least 500 complaints so far, say police

PEOPLE were told they could invest in cryptocurrency by paying ₹50,000 under 'FQL scheme' or around ₹1 lakh through the 'VG scheme'. The payment is not made using the link, but by cash in person to the agent. After payment,

scammers allegedly credited the investors' accounts with US dollars, which the latter could see by opening the link. Following this, investors were given three online tasks in their links to complete to earn a few additional dollars as commissions. In case an investor wanted to retrieve their money, they had

to raise a request, and their agent would pay them in cash. After this, their accounts displayed the balance after the debit.

The individuals were allegedly made to believe that under this copy-trading investment method, they would get twice the money after a certain peri-

od. If they continuously invest or invest more, they would be "level-two investors" and receive more interest with higher returns. Level-two investors also performed extra tasks to earn additional dollars, and be eligible for prizes such as bikes, gold jewels, among others, if they convinced more people to

invest. "At least for the last two years, the fraudsters have been operating the scam. The reason many fell into the trap was that the initial investors received their commission, interest, and returns, said the investors. The investment became popular through word of mouth. Eventually, the scam spread to

neighbouring Dindigul, said police. "We have received at least 500 petitions so far, and it is believed that thousands of people have been cheated of crores of money," added a senior police officer.

As the information spread rapidly on social media, the investors gathered in front of the

house of Ramesh and Vijay, agents, in Kasampatti village and ransacked the house on Friday, creating tension in the area. When police attempted to take Ramesh away for questioning, the protesters prevented the vehicle from leaving and threw stones and footwear at the police vehicle.
