Mr Tapas Kumar Dey (Borrower- Mortgagor) ,56/3/A, Rajen Seth Lane Flat no-404 ,4th Floor, Ward No.-14, P.S.- Bally Howrah-711202 availed credit facility from Indian Bank, Bandaghat Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". **Mr Tapas Kumar Dey** failed to pay the outstanding dues to the Bank. Therefore, a Demand Notice dated **27/12/2018** under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s)/ Guarantors **Mr. Tapas Kumar Dey (Borrower - Mortgagor), liable** to the Bank to pay the amount due to the tune of **Rs. 13,76,691.00/= (Rupees Thirteen Lacs Seventy six Thousand Six hundred and Ninty-one Only)** as on **27/12/2018** with further interest, costs, other charges and expenses thereon. All failed to make payment despite Demand Notice dated 27/12/2018.

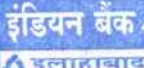
As **Mr. Tapas Kumar Dey** failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 28/03/2019 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

As per Rule 9(1) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 15 days' notice of intended for the 2nd and subsequent sale is required to be given and hence we are issuing this notice.

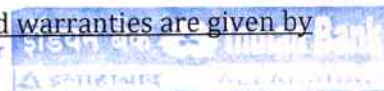
