Iran seeks compensation as oil spill reaches Qeshm

Baqaei says spills caused trillions in damage to Iran's coastal areas

PARIS

IRAN on Thursday said an oil spill had reached Qeshm island, with the slick degrading waters of the Gulf and Sea of Oman. Foreign ministry spokesman Esmail Baqaei said "preliminary evidence indicates a foreign bulk carrier as the source".

TankerTrackers, a website that monitors shipping movements, said the spill seemed to derive from an Iranian attack on bulk carrier Minoan Pioneer in Omani waters on August 3. "The spillage then drifted across the strait over to Iran," it said.

Baqaei said such spills had imposed "trillions of dollars" in damage on Iran's coastal areas, calling for compensation from those responsible. The spill had reached Qeshm island but was "almost completely cleaned up by Wednesday evening", said Habib Mashihi, head of the environmental protection department in Iran's southern Hormozgan province. He said

about 32,000 square metres of coastal area had been affected, along with waters covering 90,000 square metres.

Iran rejects Trump's Hormuz control claim

Iran's military rejected as "lies" Trump's remarks, saying the waterway was fully under Iranian control. "The false claims of the United States that ships are passing through the Strait of Hormuz normally ... are nothing more than lies and fabrications," said Ebrahim Zolfaghari, spokesperson for Iran's military command, Khatam-al-Anbiya. Iran has kept control of Hormuz

since the outbreak of the West Asia war on February 28, requiring vessels to obtain permission and pay transit fees before using the waterway.

Trump had claimed Wednesday that the US "has total control over the Strait of Hormuz", adding that its naval blockade was a "wall of steel". Iranian Behnam Saeedi said the strait was closed to US and Israeli ships. **AFP**

Putin makes first trip to disputed Kuril Islands, draws strong protest in Tokyo

MOSCOW

RUSSIAN President Vladimir Putin on Thursday made his first visit to the Kuril Islands, a Moscow-controlled Pacific archipelago that also is claimed by Japan, which voiced a diplomatic protest over the trip.

Putin visited a fish plant, a hospital and a school on Iturup, one of the volcanic chain's southern islands. He also briefly spoke to local residents and met with the governor of Russia's Sakhalin region, Valery Limarenko. Japan asserts territorial rights to the four southernmost islands of the chain, which it calls the Northern Territories. The Soviet Union took them from Japan in the final days of World War II, and the dispute kept the countries from

signing a peace treaty formally ending their hostilities.

Decades of diplomatic efforts to negotiate a settlement haven't produced any visible results. Moscow over the years has also bolstered its military presence on the Kurils in moves that appeared to underscore its firm stance in the dispute.

Japanese Foreign Minister Toshimitsu Motegi said his country "strongly protests" Putin's visit to Iturup, which Japan calls Etorofu.

"The Northern Territories, including Etorofu (Iturup) Island, are Japan's inherent territory both historically and from the perspective of international law," Motegi said in a statement. He summoned Russian Ambassador Nikolay Nozdrev to the ministry in To-

kyo and lodged a strong protest over the visit, requesting that he "promptly report the message back to Moscow," the minister told reporters afterward.

Later on Thursday, the Russian Embassy in Japan called Tokyo's protest "unfounded" and said Nozdrev had explained that "the southern Kuril Islands are an integral part of the Russian Federation and became part of it following World War II on legitimate international grounds." **AP**

Ukrainian drones strike major Russian refinery

KYIV: Ukrainian drones struck the Gazprom Neftekhim Salavat refinery in Russia's Bashkortostan, causing a fire and wounding two people, officials said. Kyiv said the facility, about 1,300 km from Ukraine, is one of Russia's largest, processing up to 74 million barrels annually. The attack was the fourth on Russian refineries in three days, as Kyiv targets Moscow's vital oil sector and seeks to disrupt fuel supplies.

India keen on Arctic cooperation: Russia

MOSCOW: India is among countries having the "most productive" talks with Russia on Arctic cooperation, a senior Russian official said Thursday. Vladislav Maslennikov said China and India showed interest in joint projects. Putin said India and China were keen to work with Moscow on the Arctic and Northern Sea Route. India's parliamentary panel recommended a "polar ambassador" to boost diplomacy.

KATHMANDU: Former Nepal prime minister Sher Bahadur Deuba returned home on Thursday after more than five months abroad for medical treatment following injuries sustained during Gen Z protests last year. Deuba and his wife, foreign minister Arzu Rana Deuba, were injured during anti-government demonstrations that toppled the K P Sharma Oli government in September 2025. Deuba, 80, was welcomed by Nepal Congress leaders and hundreds of supporters.
