

Arms licence misuse: 3rd FIR against SP MP Afzal Ansari

Varanasi: Continuing its crackdown on the Mukhtar Ansari gang, the Ghazipur police on Tuesday lodged a third FIR in a week against gangster-turned-politician late Mukhtar Ansari's elder brother and SP's Ghazipur MP **Afzal Ansari**, over alleged irregularities in records related to the sale and purchase of a firearm on his arms licence. This is the fifth FIR registered against members of the Mukhtar gang and the third against Afzal within a week.

Ghazipur SP Rajaraj said a third FIR was registered against Afzal after it came to light that the original file and



purchase-sale records related to his arms licence were found missing from the record room.

During the investigation, it surfaced that decades ago an NPB rifle was bought and sold in Aligarh, Arunachal Pradesh, on Afzal's licence. However, the file related to the transaction and the current status of the weapon are not clear. Police alleged that the records were made to disappear in collusion with the concerned arms clerks.

Based on the findings, a case was registered against Afzal, arms clerk Gaurishankar Lal and another arms clerk, Sugrivi Tiwari, at Kotwali police station in Ghaziabad under charges of chea-

ting, forgery, criminal conspiracy and relevant sections of the Arms Act, Raja said. He added that since July 22, this is the third FIR against Afzal, while a total of five FIRs have been lodged against members of the Mukhtar gang. Further investigation into the remaining arms licences is continuing.

On the orders of the DIG, Varanasi Range, physical verification is being carried out of 51 arms licences issued to people linked to the IS-191 gang, including Mukhtar and his family members, and 145 weapons bought and sold on those licences. For this, separate teams of circle officers and station house officers have been formed under the leadership of the ASP (City) and ASP (Rural).

Varanasi: Ahead of UP and Punjab polls in 2027, the BJP will launch its mega Dalit outreach programme from Sant Ravidas Temple in Varanasi on Wednesday by taking out a countrywide Kalash Yatra. For this, BJP workers will carry 13 urns from the birthplace of 15th-century poet-saint Sant Ravidas to different parts of the count-

The mega event will be flagged off on Wednesday in the presence of the UP CM Yogi Adityanath and the party's national president Nitin Nabin. The temple has remained the nucleus of the BJP's Dalit outreach since 2008, with Prime Minister Narendra Modi visiting it three

times since 2016. Led by BJP SC Morcha national president Lal Singh Arya and state general secretary (organisation) Dharampal Singh, party workers gathered near the Ravidas Temple on Tuesday and filled 131 urns with soil from the saint's birthplace. After worshipping the kaalash, the party also organised a religious procession carrying the urns.

On Wednesday, Yogi, Nabin and state president Pankaj

raj Chaudhary will flag off the "Shri Guru Ravidas Mahaharaj Samasta Sankalp Abhiyan" with the same 13 urns to mark the 650th Parvati Jayanti. The campaign will be formally inaugurated on Guru Purnima on Wednesday and, following a series of programmes, will conclude on Maghi Purnima (26 February). Maghi Purnima is celebrated as Ravidas Jayanti.

The political significance of the temple increased when the Government of Mayawati tried to develop a grand park at Sant Ravidas birthplace in Ser Gowardhan hamlet in 1997, although the plan was shelved for the dominance of local population.

The BSP supreme leadership the Ravidas Jayanti celebrations as chief minister in 2008 and gifted a golden plate to the temple. The Government also sponsored the creation of Ravidas Park and a ghat in the saint's name along the Ganga. Following Mayawati's fall, the Government from the Shivraj Singh Government

gan visiting the Ravidas temple as part of their Dalit outreach efforts. Prime Minister Narendra Modi attended the temple in Jalandhar during his visit to Punjab in 2016 and 2019 and also visited the temple in 2023. After participating in the temple's annual celebrations in 2018, CM Yogi visited the temple several times to monitor the ambitious project to build a temple complex at the saint's birthplace.

Apart from them, Congress MP Rahul Gandhi and BJP MP Anurag Thakur visited Delhi chief minister and AAP chief Arvind Kejriwal and former Punjab chief minister Bhupinder Singh Hooda. Modi has also visited the temple in recent years.

The satiating ground of the temple is owned by the Gowardhanpur which witnessed the foiling of a Maoist's wild dream project by SI and functionaries in 1997, later the SI was killed in an encounter. SI-BSP grand alliance for the 2019 Lok Sabha elections addressed by Akhilesh Yadav in 2019.

Sharma said selected teachers will also be honoured during the programme. One teacher from the university and three teachers from affiliated institutions will be selected for the honour after evaluation.

Neighbour held for kidnapping over murdering minor boy in Gorakhpur

Gorakhpur: A 10-year-old boy who went missing while playing outside his house in Gorakhpur's Khasi town, was allegedly kidnapped and murdered by a neighbour, police said on Tuesday.

The child's body was recovered from the basement of the accused's house, barely 20 metres from the deceased's house.

The deceased, a Class IV student and grandson of a prominent jeweller, had gone missing on Monday afternoon after returning from school. According to police, he reached home around 3pm, changed his school uniform and left on his bicycle to play in the neighbourhood.

When he did not return, family members began searching for him. He was later found abandoned near the house, while one of his slippers was recovered from a nearby field, police said.

After the body was recovered, his family lodged a complaint with police, following which
