9. 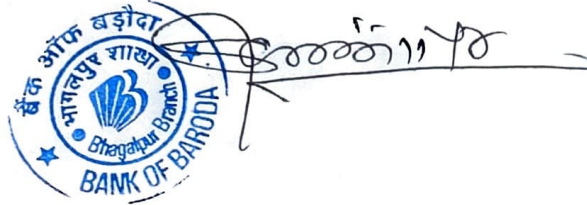
