Reem Sithara

Malappuram district medical officer Vinod said, "Her condition was reportedly critical while she was undergoing treatment at the hospital in Kondotty. She died after reaching a private hospital in Kozhikode and undergoing treatment. No complaints have been received so far. However, an inquiry will be conducted," he said.

Malappuram: A migrant worker was arrested on Monday in connection with the death of his friend, whose body was found beneath a four-storey building near Edavannapara in Malappuram. The arrested has been identified as Sunil Kiro, 38, a native of Jharkhand. The deceased, Prakash, 47, was also from Jharkhand. Police suspect that Prakash was killed following a dispute between the two, who worked as daily-wage labourers and were staying in the same building. During a quarrel on Saturday midnight, Sunil allegedly assaulted Prakash and repeatedly struck his head against a wall. Prakash became unconscious following which Sunil carried him to a window on the top floor which had no protective grills and threw him outside.

10 booked for road blockade

Mananthavady: Police have booked 10 persons, including CPM district committee member P T Biju and party leaders A K Raishad, K V Jubair, Ajith Varghese and K Rajeevan, for allegedly obstructing traffic and holding a protest on a public road. The protest was organised by the CPM in Kaniyaram against the poor condition of the Kaniyaram-Pilakkavu road.

FOLLOWING wide-spread public outrage over inflated food and beverage pricing in cinema multiplexes, a joint inspection team comprising officials from the Legal Metrology, Civil Supplies and Food Safety departments carried out surprise raids on Monday at prominent multiplex cafes across Kozhikode, including the Blue Diamond Mall theatre complex. The coordinated operation was initiated to address complaints regarding the financial exploitation of moviegoers.

During the inspections, enforcement officers uncovered severe pricing irregularities, lack of standardisation and critical compliance failures. Vendors were found charging up to ₹100 for a modest 180ml cup of tea, with starting prices for coffee fixed at ₹130. The team also identified dynamic pricing strategies, where item rates surged significantly during peak weekend days compared to standard weekday prices. Snacks such as popcorn were being sold at rates well exceeding ₹370.

The Food Safety department issued formal notices to non-compliant establishments for failing to maintain required storage temperatures in storerooms, neglecting prescribed food safety guidelines for items kept for sale and failing to produce medical fitness certificates for all employees. Theatre outlets have been directed to ensure free drinking water readily accessible to moviegoers and to prominently display a price board in a prescribed standard format.

A food safety officer said, "For pre-packaged items, prices are marked by manufacturers and vendors cannot charge above the Maximum Retail Price (MRP). For loose items like popcorn, sellers must clearly display the exact quantity alongside the price, and the supplied quantity must not fall below the stated amount."
