- c) The intending bidders shall deposit Earnest Money Deposit (EMD) mentioned above, being of 10% of the Reserve Price in E-Wallet of M/s PSB Alliance Private Limited (BAANKNET) portal directly or by generating the Challan therein to deposit the EMD through RTGS/NEFT in the account details as mentioned in the said challan on or before 27-09-2026 at 05:00 PM.
