Mr. P THANGAVEL and Mrs. T SIVAGAMI availed HI19 SAL TAKE OVER (A/c No 6820782059) AND IBHL PLUS (A/C NO -6837226821) from Indian Bank, Pennagaram Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". P THANGAVEL and Mrs. T SIVAGAMI failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 13.04.2026 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower(s), P THANGAVEL and Mrs. T SIVAGAMI liable to the Bank to pay the amount due to the tune of Rs. **27,96,011/- (Rupees Twenty seven lakhs ninety six thousand and eleven Only)** as on 13.04.2026 with further interest, costs, other charges and expenses thereon.
