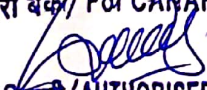

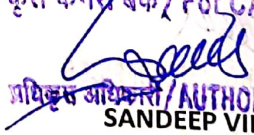

- c) The property will be sold for the price which is more than the Reserve Price and the participating bidders may improve their offer further during auction process.
- d) EMD amount to be deposited by way of Demand draft in favour of Authorized Officer, Canara Bank, Shiroda[15373] Branch OR shall be deposited through RTGS/NEFT/Fund Transfer to credit of collection account of Canara Bank, A/c No 209272434 IFSC Code: CNRB0015373 on or before 28.09.2026 12:00 PM.
