Mr. Mohd. Ashraf (A/c No:50252731940) with Indian Bank, Kalal Kheriya Agra, Agra Branch facility from Indian Bank, Kalal Kheriya Branch and, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". **Mr. Mohd. Asharaf** failed to pay the outstanding dues to the Bank.
