M/s ACME Industries, M/s Stelco Industries, M/s Bossteel Industries & M/s Boskina Impex availed MSME Loans from Indian Bank, Santacruz Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". M/s ACME Industries, M/s Stelco Industries, M/s Bossteel Industries & M/s Boskina Impex failed to pay the outstanding dues to the Bank. Therefore, Demand Notices dated 08.05.2026 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer for respective A/cs calling upon Borrower (s), Guarantor(s) M/s ACME Industries, M/s Stelco Industries, M/s Bossteel Industries, M/s Boskina Impex, Mr. Sameer Pankaj Shah, Mrs. Daya Pankaj Shah, Mrs. Deepa Sameer Shah, Sameer Pankaj Shah HUF & Coparceners of Sameer Pankaj Shah HUF liable to the Bank to pay the amount due to the tune of to Rs. 38,93,418.89 (Rupees Thirty-Eight Lakhs Ninety-Three Thousands Four Hundred Eighteen and paisa Eighty-Nine only), Rs. 82,30,378.56 (Rupees Eighty-Two Lakhs Thirty Thousands Three Hundred Seventy-Eight and Paisa Fifty-Six only), Rs. 42,23,325.16 (Rupees Forty-Two Lakhs Twenty-Three Thousands Three Hundred Twenty-Five and paisa sixteen only) and Rs. 80,65,652/- (Rupees Eighty Lakhs Sixty-Five Thousands Six Hundred Fifty-Two only) for respective accounts as on 07.05.2026 with further interest, costs, other charges and expenses thereon. All of you failed to make payment despite Demand Notice dated 08.05.2026.

All of you have failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 30.07.2026 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance.
