Mr Murgan S Mudaliyar availed Loan facility from Indian Bank, Ulhasnagar East (New Era School) Branch the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as “the Properties”. Mr Murgan S Mudaliyar failed to pay the outstanding dues to the Bank. Therefore, a Demand Notice dated 04.07.2022 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as “The Act”), was issued by the Authorized Officer calling upon Borrower(s), Guarantor(s) M/s T Bros Enterprises, Mr Murgan S Mudaliyar & Mrs. Nanda Murgan Mudaliyar liable to the Bank to pay the amount due to the tune of Rs.53,14,774/- (**Rupees Fifty Three Lakhs Fourteen Thousand Seven Hundered and Seventy Four Only**) per demand notice dated 04.07.2022 with further interest, costs, other charges and expenses thereon. All failed to make payment despite Demand Notice.

As M/s T Bros Enterprises, Mr Murgan S Mudaliyar & Mrs. Nanda Murgan Mudaliyar to make payment despite Demand Notices, the Authorized Officer took possession of the schedule mentioned properties under the Act after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with

the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

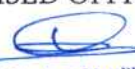
