Mr. Manas Kumar Acharya and Mrs. Krishna Acharya availed credit Facility/ies from Indian Bank, Southern Avenue Branch, Kolkata, the repayment of which is secured by Mortgage /creation of security interest of schedule mentioned properties hereinafter referred to as "the Properties". **Mr. Manas Kumar Acharya (Borrower) & Mrs. Krishna Acharya (Borrower)** failed to pay the outstanding dues to the Bank. Both failed to make payment despite Demand Notice dated 11/04/2026

As Mr **Mr. Manas Kumar Acharya and Mrs. Krishna Acharya** being the Borrower / Guarantor failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 28/07/2026 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:
