Mr. Dhanaraj Arukketty Sreedharan and Mrs. Sithu V S availed HLNRICRE-ELITE-CBL751-771: 7523443110 facility from Indian Bank, M G Road, Ernakulam Branch, Mr. Dhanaraj Arukketty Sreedharan is the mortgagor who has offered their assets as security to the loan, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Mr. Dhanaraj Arukketty Sreedharan and Mrs. Sithu V S had failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 07.01.2025 (published in newspaper on 19.01.2025) under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Mr. Dhanaraj Arukketty Sreedharan and Mrs. Sithu V S liable to the Bank to pay the amount due to the tune of Rs. 50,09,210.00 /- (Rupees Fifty Lakhs Nine Thousand Two Hundred and Ten only) for HLNRICRE-ELITE-CBL751-771 as on 06.01.2025 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 07.01.2025.

Mr. Dhanaraj Arukketty Sreedharan and Mrs. Sithu V S failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 24.03.2025 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

*As per Rule 6(2), 8(6) and 9(2) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 15 days' notice of intended sale is required to be given for subsequent sales and hence we are issuing this notice.

The amount due as on 08.09.2026 is **Rs. 58,01,166.00 (Fifty Eight Lakhs One Thousand One Hundred and Sixty Six only)** with further interest, costs, other charges and expenses thereon from 09.09.2026.

Please take note that this is notice of 15 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 15 days.

The date of sale is fixed as 28th September 2026 which would be by e-auction mode.

Inspection of the scheduled properties and related documents/up to date EC etc. by the intending purchasers/bidders may be done at their expense from **10.09.2026 to 25.09.2026** between **10.00 am to 4.00 pm.**

The Reserve price and Earnest Money Deposit (EMD) for the sale of the secured assets is fixed as mentioned in the schedule

The intending Bidders/ Purchasers are requested to register with online portal (<https://baanknet.com> (PSB Alliance Pvt. Ltd.)) using their mobile number and email id. Further, after completing their eKYC, the intending Bidders/ Purchasers have to transfer the EMD amount in their e-Wallet by **28.09.2026**. i.e the e-Auction Date and before the e-auction end time in the portal. The registration and eKYC must be completed well in advance, before auction.

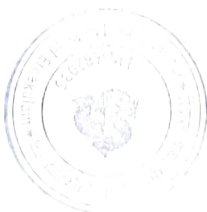
