PATANJALI, PROP – NIPUN SAURABH SHARMA (Borrower failed to pay the outstanding dues to the Bank. Therefore, a Demand Notice dated 06/05/2024 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower(s), Guarantor(s) ".M/s V-RISE ENTERPRISES, PROP – RIZUN SAURABH SHARMA (Borrower) AND M/s SRI SRI PATANJALI, PROP – NIPUN SAURABH SHARMA (Borrower liable to the Bank to pay the amount due to the tune of Rs. 61,74,853.00(Rupees Sixty-One Lacs Seventy-Four Thousand Eight Hundred Fifty-Three only) M/s V Rise Enterprises: Rs.3099846.00 and M/s Sri Sri Patanjali: Rs.3075007.00 per demand notice dated 06.05.2024 with total amount of **9414950** (Rupees Ninty Four lakh Forteen thousand Nine hundred Fifty Only) with further interest, costs, other charges and expenses thereon. All failed to make payment despite Demand Notices dated 06.05.2024.

As M/s V-RISE ENTERPRISES, PROP – RIZUN SAURABH SHARMA (Borrower) AND M/s SRI SRI PATANJALI, PROP – NIPUN SAURABH SHARMA (Borrower failed to make payment despite Demand Notices, the Authorized Officer took possession of the schedule mentioned properties under the Act after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

*As per Rule 9(1) of the Security Interest (Enforcement) Rules 2002, 15 days' notice for subsequent sale is required to be given and hence we are issuing this notice.

The amount due as on 09.09.2026 is Rs 9414950.00 (Rupees Ninty-four lakh fourteen thousand Nine hundred Fifty Only) with further interest, costs, other charges and expenses thereon from 09.09.2026
