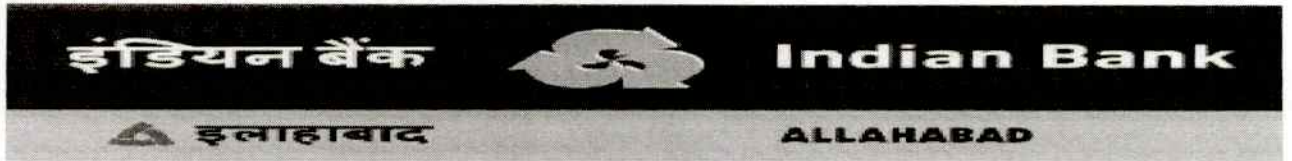

1.
