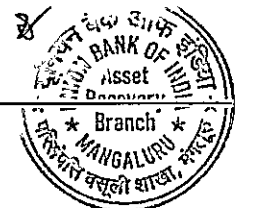

16. 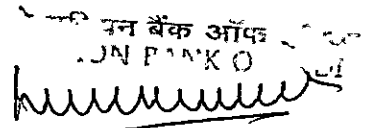
