Notice of sale under Rule 6(2) & 8(6) of The Security Interest (Enforcement) Rules 2002 under The Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002

Sub : Your Loan Account No.6839160967 of Mrs. V. Sivagamasundari and Mrs. V. Rajalakshmi with Indian Bank, Padappal Branch.

Mrs. V. Sivagamasundari and Mrs. V. Rajalakshmi availed loan facility from Indian Bank, Padappal Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Mrs. V. Sivagamasundari and Mrs. V. Rajalakshmi failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 15.04.2026 under Sec. 13(2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling Mrs. V. Sivagamasundari and Mrs. V. Rajalakshmi & others liable to the Bank to pay the amount due to the tune of **Rs.25,52,300.40 (Rupees Twenty five lakhs fifty two thousand three hundred and paise forty only)** with further interest, costs, other charges and expenses thereon. All failed to make payment despite Demand Notice dated 15.04.2026.

As Mrs. V. Sivagamasundari and Mrs. V. Rajalakshmi failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 06.07.2026 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

As per Rule 6(2) and 8(6) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 30 days notice of intended sale is required to be given and hence we are issuing this notice.

The amount due as on 31.08.2026 is **Rs.26,84,460/- (Rupees Twenty six lakhs eighty four thousand four hundred and sixty only)** with further interest, costs, other charges and expenses thereon from 01.09.2026.

Please take note that this is notice of 30 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 30 days.

The date of sale is fixed as 05.10.2026 from 10.00 a.m. to 4.00 p.m. which would be by e-auction mode.

Inspection of the scheduled properties and related documents/up to date EC etc by the intending purchasers/bidders may be done at their expense from 28.09.2026 to 29.09.2026 between 10.00 am and 4.00 pm.

The Reserve price and Earnest Money Deposit (EMD) for the sale of the secured assets is fixed as mentioned in the schedule.

The intending Bidders/Purchasers are requested to register with online portal (<https://www.baanknet.com>) using their mobile number and email id. Further, after completing their eKYC, the intending Bidders/Purchasers have to transfer the EMD amount in their e-Wallet before the e-Auction Date and time in the portal. The registration, eKYC and transfer of EMD in wallet must be completed well in advance, before auction.

Earnest Money Deposit (EMD) amount as mentioned above shall be paid online or after generation of Challan from the website (<https://www.baanknet.com>) **for depositing in bidders e-Wallet**.
