Mr.Sadath Ismail (Borrower) and Mrs. Shajila (Co-Borrower) availed Home Loan facility from Indian Bank, Lawspet Branch. The repayment of loan is secured by Mortgage of schedule mentioned properties. Mr.Sadath Ismail (Borrower) and Mrs. Shajila (Co-Borrower) failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 11.06.2018 under Sec. 13(2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower and Co-Borrower liable to the Bank to pay the amount dues to the tune of Rs. 27,01,917.23/- (Rupees Twenty Seven Lakhs One Thousand Nine Hundred and Seventeen and Paise Twenty Three Only) as on 11.06.2018 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 11.06.2018.

As Mr.Sadath Ismail (Borrower) and Mrs. Shajila (Co-Borrower) failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 03.09.2018 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends to sell the schedule mentioned securities in the following mode:
