Whereas the undersigned being the Authorized Officer of the Bank of Baroda u/s 13(2) of the above said SARFAESI Act, 2002 and in exercise of the powers conferred u/s 13(2) of the said Act read with Rule 3 Issued a Demand Notice on **01-12-2018** calling upon the Borrower(s)/Guarantor(s)/Corporate Guarantor(s) of **Mrs. KOMAL BUKOLIYA W/O Mr. SONU SHARMA and Smt. NISHA BUKOLIYA W/O MANOJ BUKOLIYA** to repay the amount in terms of the said notice within 60 days from the date of the said notice.
