charges and expenses thereon. Both failed to make payment despite Demand Notice dated **05.02.2025**.

As **Mr.Anudev Ramadevan and Mrs.Rani Ramadevan** failed to make payment despite Demand Notice, the Authorized Officer took **POSSESSION** of the schedule mentioned properties under the Act on **19.05.2025** after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. 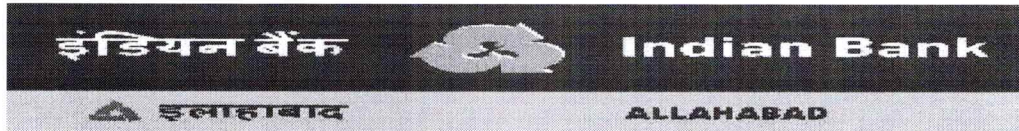
