Bijoy Chowdhury failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 18.09.2019 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s)/ guarantor(s)/ mortgagor(s) Bijoy Chowdhury S/o Kalika Prasad Chowdhury (Borrower/Mortgagor), 15, Police Line Road, Sadar Bazar, Barrackpore, North 24 Parganas, Barrackpore Head Post Office, WB 700120, Purnima Chowdhury W/o Bijoy Chowdhury(Guarantor), 15, Police Line Road, Sadar Bazar, Barrackpore, North 24 Parganas, Barrackpore Head Post Office, WB 700120 liable to the Bank to pay the amount due to the tune of of **Rs. 19,68,322.69 /- (Rupees Nineteen Lakhs Sixty-Eight Thousand Three Hundred Twenty-Two and Sixty-Nine Paise Only)** as on 18.09.2019 with further interest, costs, other charges and expenses thereon. All failed to make payment despite Demand Notice dated 18.09.2019.

As Bijoy Chowdhury and Purnima Chowdhury failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 07.12.2019 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. As per Rule 9(1) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 15 days' notice of intended for the 2nd and subsequent sale is required to be given and hence we are issuing this notice.

The amount due as on 14/09/2026 is of Rs 35,92,350/- (Rupees Thirty-five Lakhs Ninty two Thousand Three Hundred Fifty Only) with further interest, costs, other charges and expenses thereon from 15.09.2026.
