

RBI’s swap facility fuels India’s forex reserves to defend rupee

NEW DELHI, Sept 3 (IANS)

THE Reserve Bank of India's special swap windows raised a cumulative \$136.3 billion by end-August exceeding market estimates by a wide margin, likely pushing foreign reserves past \$750 billion and giving the Central Bank firepower to defend the rupee, a report said on Thursday.

Further, the surge has already been reflected in a shift in intervention bias as USD-INR corrected sharply, testing below 95 handle to mid-94 due to strong intervention dollar sales and broader dollar swings, the report from DBS Bank said. Nearly 92 per cent of the inflows came via FCNR (B) deposits at \$126 billion, with the remainder through off-shore borrowing facilities. “Given the swap arrangement, these inflows will add to an already abundant INR liquidity backdrop, which was at a four year high this month, depressing overnight rates,” said Radhika Rao, Senior Economist and Executive Director, DBS Bank.

Organic drivers such as tax-related outflows, seasonal currency leakage, a current account deficit of about 1.1 per cent of GDP, portfolio outflows and maturity of the forward books will act as counter-balancing factors, yet concerted steps are necessary to drain the potential surge in liquidity.

The report also highlighted effects on bunched-up deposit maturities in three- and five-year tenors.

“A portion of the existing reserve stock could be earmarked against these liabilities, helping to mitigate concerns that deposit maturities or debt repayments could trigger a sharp increase in dollar demand and exert pressure on the FX market down the line,” the report said.

Traders forecasted that Rupee will fluctuate between the immediate trading band of Rs 94.10–Rs 95.50 and a decisive break below Rs 94.10 could open way to near Rs 93.50.

Market participants expect the Central Bank to rebuild reserves and curtail INR depreciation, while the rupee is also buoyed by broader Asian

Upcoming FTAs to help India gain access to 75% global trade: Goyal

NEW DELHI, Sept 3 (IANS)

COMMERCE and Industry Minister Piyush Goyal on Thursday said that combined with upcoming free trade agreements (FTAs) and efforts to deepen market access, India could gain access to 75 per cent of global trade at rates lower than competitors.

India's nine FTAs spanning economies with about \$60 trillion GDP will provide preferential access to nearly two-thirds of global trade, Goyal said at an event here, calling for a focused, inclusive and nationwide effort to maximise the utilisation of FTAs to expand India's trade across the world and ensure that the benefits of enhanced market access reach businesses across the country.

Addressing the National Workshop on “Leveraging FTAs an Outreach Programme” the Minister emphasised the need for a concerted effort to translate India's expanding network of FTAs into greater export opportunities for businesses across the country.

The initiative should rapidly take roots across the country and reach the last person, smallest businessperson, trader, entrepreneur, startup and woman entrepreneur across all 780 Districts, big and small, said Goyal. Every contribution, big or small, would be invaluable in achieving the larger objective of transforming India from a largely inward-looking domestic economy into an international player of significance, he added.

The other FTAs that India would conclude over the next few months and couple of years include with Canada, Mexico, Chile, Mercosur, SACU, GCC and Israel, together with efforts to review ASEAN, Korea and Japan or take other steps to secure greater market access.

FSSAI takes actions against CG Foods

NEW DELHI, Sept 3 (PTI)

FOOD regulator FSSAI on Thursday said it has directed CG Foods India to stop production of ‘veg bhujia namkeen’ after it found many violations of rules during inspection, including hygiene issues.

In a social media post, the Food Safety and Standards Authority of India (FSSAI) informed that it has initiated enforcement action against CG Foods India Pvt Ltd in view of “unsafe processing, unlicensed bhujia manufacturing, and predated packaging”.

“The unit was found re-processing floor-collected, broken noodles into bhujia products without heat treatment, along with using predated packaging dates. Unlicensed manufacturing of ‘Wai-Wai MaMa’ and ‘Wai-Wai Mama Punte’ bhujia variants was identified in direct violation of Section 31 (1) of the FSS Act, 2006,” FSSAI said. The food watchdogs seized 32,107.2 kg of stock on-site, including loose broken noodles.

“The inspection revealed several hygiene and documentation deficiencies, including inadequate pest-control records and other deficiencies relating to food hygiene and safety,” FSSAI said.

The regulator collected samples for laboratory analysis.
