M/s. DCC Interiors Pvt Ltd, Represented by its Directors : Mr. K. Devendiran and Mrs. D. Sasikala availed loan facilities from Indian Bank, Maraimalai Nagar Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". **M/s. DCC Interiors Pvt Ltd, Represented by its Directors : Mr. K. Devendiran and Mrs. D. Sasikala** failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated **17.03.2026** under Sec. 13(2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling **M/s. DCC Interiors Pvt Ltd, Represented by its Directors : Mr. K. Devendiran and Mrs. D. Sasikala & another** liable to the Bank to pay the total amount due to the tune of **Rs.1,66,36,508/- (Rupees One crore sixty six lakhs thirty six thousand five hundred and eight only)** as on **17.03.2026** with further interest, costs, other charges and expenses thereon. All failed to make payment despite Demand Notice dated **17.03.2026**.

As **M/s. DCC Interiors Pvt Ltd, Represented by its Directors : Mr. K. Devendiran and Mrs. D. Sasikala** failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on **09.06.2026** after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:
