Mr. Ashwin Chhaganlal Ramani & Mrs. Sheetal Ashwin Ramani availed Home Loan facility from Indian Bank, Badlapur West Branch, and the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as “the Properties”. All failed to make payment despite Demand Notice.

Mr. Ashwin Chhaganlal Ramani & Mrs. Sheetal Ashwin Ramani to make payment despite Demand Notices, the Authorized Officer took possession of the schedule mentioned properties under the Act after complying with all legal formalities.

The date of sale is fixed as 22.09.2026 which would be by e-auction mode.

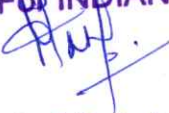
