

Horrific Kerala car crash nips many a dream in the bud

THE phone call at the odd hour brought his world crashing down, for what was conveyed to M Karthikeyan by the Kerala police at the other end was beyond his worst nightmare. It took a while for the father of K Yuvasanjith (21) to come to terms with the reality - that his son would never return from his trip to Kerala.

Speaking to *TNIE*, Karthikeyan, a financier from Anna Nagar in Athikombai panchayat in Oddanchatram in Dindigul, said he allowed his eldest son to go to Kerala with his friends as it was a holiday. "It was on Friday morning that Yuvasanjith told me regarding the trip. He left the house in the afternoon, promising us that he would return on Saturday evening. Unfortunately, it was the Kerala police who contacted us with the bad news," said the father, overwhelmed with emotions. He recalled that his son wanted to pursue a career in the construction industry.

Yuvasanjith apart, seven more students of a private engineering college in Dindigul died in the fatal accident in Thrissur district in Kerala on Friday night.

THE bodies were shifted to a private hospital in Kodungallur for further procedures. Hospital authorities have arranged ambulances to transport the bodies to their respective native places.

Using student ID cards recovered from the site, Kaipamangalam police contacted their family, some of whom were unaware of their sons' trip to Kerala. Santhosh's relatives told the police that

he had recently purchased a car and that the group had planned a trip to Kochi. As the registration of the car was not complete, they had hired a rented vehicle for the trip.

The National Highways Authority of India (NHAI) is facing questions over alleged safety lapses after ambulance driver Shahul, one of the first to reach the accident site, along with accounts from residents, pointed to inadequate safety arrangements on the highway.

Literature provides solace: Arif Khan

GREAT works of literature provide people with emotional and spiritual comfort, particularly during difficult and anxious times, said veteran politician, scholar and former Governor of Kerala and Bihar, Arif Mohammad Khan, on Saturday.

Inaugurating the 14th Odisha Literary Festival (OLF), organised by The New Indian Express, in presence of *TNIE* editorial director Prabhu Chawla and *TNIE* Group CEO Lakshmi Menon at Hotel Mayfair Con-

vention here, Khan said, "In difficult times, when we are anxious, we turn to great works of literature and poetry. They do not merely entertain us. They give us solace of mind."

Speaking on what inspires writers and poets, he said, it is often an emotional or spiritual injury that turns a person into an author or poet. "However, one need not personally experience such an injury. For

sensitive minds, there are so many things happening around us that disturb our conscience.

We feel concerned about them and this makes us participants in them," he said, citing Adi Kabi Valmiki, who wrote the Ramayana, as a great example.

Khan also spoke about the purpose of life, and should it be pursuit of pleasure or knowledge! Quoting Swami Vivekananda, Khan said according

to him, it cannot be pursuit of pleasure. The purpose of life is pursuit of knowledge. The purpose of knowledge is to develop the ability to see the innate oneness in the diversity around us. The diversity should be accepted and respected, knowing that it is not real, he said. "What we see here is everyone sitting in this hall. There are people with different appearances, people who speak different languages and have different food habits. The purpose of knowledge is to develop the ability to see the inherent oneness behind this apparent diversity," he said.

DVAC search vendetta, says Nehru

NEHRU'S review petition against the court's direction has been heard and orders are reserved. The ED's third communication in January pertained to alleged corruption in transfers and postings of MAWS officials.

In Tiruchy, DVAC officials searched Nehru's residence on Thillai Nagar 5th Cross Road from around 8 am to 3 pm. His former personal assistant Manikandan's residence at Periyar Nagar in Srirangam was also searched.

Speaking after the search, Nehru said officials had taken a copy of what he described as a "routine" file from his residence and a slip relating to income and expenditure accounts from his brother's Chennai office. He denied having spoken to anyone regarding tenders and termed the case a political vendetta.

"Politically speaking, they are attempting to threaten us. We will face the case legally and come out clean," he said. A large number of DMK functionaries gathered outside Nehru's residence during the

search. Former minister Anbil Mahesh Poyyamozhi, Manachanallur MLA S Kathiravan and Tiruchy Mayor Mu Anbalagan were among those present.

In Coimbatore, DVAC officials searched a real-estate office owned by Nehru's brother KN Manivannan at an apartment complex near Ramanathapuram on Trichy Road. A separate search was conducted at the Sungam residence of a former Coimbatore Corporation employee who headed its Town Planning Department. Sources said the searches there were linked to irregularities in building and layout approvals.
