M/S Chhattisgarh Petrochemical, M/s Shree Bhavya, Smt Rekha Pandey W/o Shivji Pandey & Shivji Pandey S/o Ramakant Pandey availed OCC & Housing loan facility from Indian Bank, DDU Nagar Raipur Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". M/s Chhattisgarh Petrochemical, M/s Shree Bhavya, Smt Rekha Pandey W/o Shivji Pandey & Shivji Pandey S/o Ramakant Pandey failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 29.03.2025 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower(s), Guarantor(s) M/S Chhattisgarh Petrochemical, M/s Shree Bhavya, Smt Rekha Pandey W/o Shivji Pandey & Shivji Pandey S/o Ramakant Pandey liable to the Bank to pay the amount due to the tune of **Rs 4752316.00 (Rupees Forty Seven Lacs Fifty Two Thousand Three Hundred & Sixteen Only)** as on 28.03.2025. with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 29.03.2025.

As M/s Chhattisgarh Petrochemical, Rekha Pandey & Shree Bhavya failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 08.07.2025 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

As per Rule 9(1) of the Security Interest (Enforcement) Rules 2002, 15 days notice for subsequent sale is required to be given and hence we are issuing this notice.

The amount due as on 02.09.2025 is **Rs 5575540.00 (Rupees Fifty Five Lacs Seventy Five Thousand Five Hundred & Forty Only)** with further interest, costs, other charges and expenses thereon from 24.07.2026.

Please take note that this is notice of 15 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 15 days.

The date of sale is fixed as 02.11.2026 which would be by e-auction mode.

The Reserve price and Earnest Money Deposit (EMD) for the sale of the secured assets is fixed as mentioned in the schedule

The intending Bidders/ Purchasers are requested to register with online portal (<https://baanknet.com> (PSB Alliance Pvt. Ltd.) using their mobile number and email id. Further, after completing their eKYC, the intending Bidders/ Purchasers have to transfer the EMD amount in their e-Wallet by 07.09.2026 i.e the e-Auction Date and before the e-auction end time in the portal. The registration and eKYC must be completed well in advance, before auction.
