LDF govt.'s approach to toddy industry was flawed: Viswam

Communist Party of India (CPI) State secretary Binoy Viswam has launched a scathing attack against the policies of the previous Left Democratic Front (LDF) government, accusing the administration of adopting double standards towards toddy shops and bars.

Speaking at the Kerala Samsthana Chethu Thozhili Federation (KSCTF) State conference in Vailom, he observed that the previous government adopted a wrong approach towards the toddy-tapping industry and its workers, failing to take any action to protect traditional labourers.

Mr. Viswam revealed that despite the CPI repeatedly raising the demand in LDF meetings to reduce the 400-meter distance limit of toddy shops from educational institutions and places of worship, no action was taken. "In stark contrast, the LDF government reduced the distance limit for bars owned by elites to just 50 meters, clearly demonstrating a dual policy toward toddy shops and bars. LDF has a political obligation to protect traditional sectors like toddy, handloom, cashew,

and beedi," he said. He added that although Pinarayi Vijayan and other leaders agreed with the CPI's point during front meetings, the government wasted five years without doing anything.

Calls for introspection
Calling for serious introspection within the LDF leadership over the defeat in the last Assembly elections, Mr Viswam pointed out that even the front's loyal supporters did not vote for them. While acknowledging that it was wrong for party members to withhold their votes, he stressed that the LDF must identify the reasons behind this alienation and understand why the public drifted away.

Turning his criticism toward the Congress, Mr. Viswam said if Jawaharlal Nehru were alive today, Chief Minister V.D. Satheesan would have received the harshest rebuff from him. He argued that Mr. Satheesan's stances completely reject Nehru's true political ideals and traditions, leading the Congress along paths that a Nehruvian Congress could never have imagined. He added that Congress is merely using Nehru's name as a cover to conceal its own political mistakes.

The accused, identified as Biju, was caught by the Vigilance officers. He was arrested on the complaint by a Panavoor native who had approached the Nedumangad police station for documents related to a road accident.

Bank accounts belonging to deceased persons were allegedly used to route transactions worth around ₹10 crore in six months by a drug trafficking network under investigation following the recent seizure of 1 kg of MDMA at Pantheerankavu in Kozhikode.

The accounts, described by investigators as "mule accounts", reportedly belonged to deceased persons. According to the police, the accounts were obtained after promising financial returns and were subsequently used by members of the alleged drug network to receive and transfer money, mak-

ing it difficult for the police to trace the actual beneficiaries.

The latest finding has opened up a new financial trail in the investigation. Officers are continuing with the scrutiny of various other bank transactions as well over the past six months to establish the flow of money and identify other members of the network.

Accused arrested

The investigation has already led to the arrest of two more suspected synthetic drug traffickers from Noida. C. Ajmal, a native of Nilambur in Malappuram, and P. Surya, a native of Malayinkeezhu in Thiruvananthapuram, were arrest-

ed from a rented apartment there on September 12. According to police sources, Ajmal operated as a major supplier, procuring MDMA and methamphetamine in bulk from Delhi and arranging their transportation to Keralam through hired carriers and drug peddlers. Surya, a nursing student in Bengaluru and his friend were allegedly staying with Ajmal in the Noida apartment, the sources said.

A police team from Kozhikode raided the apartment before the arrests. Several packets and machines allegedly used for packing drugs were recovered from the premises, according to the police. The two were brought to

Kozhikode on September 13 for further investigation and were subsequently remanded by the Vadakara Special Court.

Four other drug pushers had earlier been arrested in connection with the Pantheerankavu case, which was registered in May 2026. Subsequent investigation found that the drugs seized from the group had been supplied by Ajmal from Delhi.

The probe also revealed Ajmal's alleged links with another major drug seizure in Keralam. A senior police officer with the special squad said his involvement in the recent seizure of over 12 kg of MDMA in Malappuram had also come to light.

Investigators are examining the possible links between these cases and a few other incidents in which commercial quantity drugs were seized. The use of mule accounts for financial transactions had also been detected in the investigation, according to the police. The accused reportedly told investigators that the drugs were sourced from Nigerian nationals.

Cyber Shield, a platform of the police and bank officials to zero in on suspicious transactions using mule accounts, is also active in Kozhikode city. Police sources revealed that several bank accounts are now under the scanner across the State.
