The intending bidders shall deposit Earnest Money Deposit (EMD) of Rs. 1,89,000 (Rupees One Lakh Eighty Nine Lakh) being of 10% of the Reserve Price in E-Wallet of M/s PSB Alliance Private Limited (BAANKNET) portal directly (online) or by generating the Challan therein to deposit the EMD through RTGS/NEFT in the account details as mentioned in the said challan on or before 30.10.2026 before 17.00 hrs.

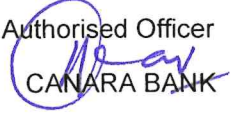
