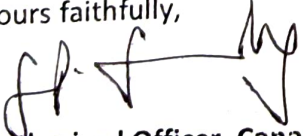
Madam/Dear Sir,

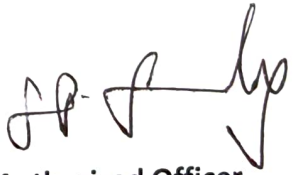
