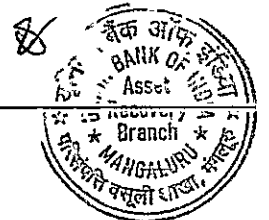

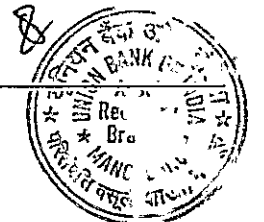

10. 2. KYC Verification

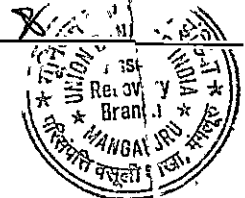

16.
